Action Item 2: Proposal for a 3-way stop sign at the corner of El Comal and Amaro Drive; Greg Zweibel; grampygreg@att.net

The residents that live by this corner have been working with city traffic engineers since 2019 to get the stop signs installed. Engineers have approved a one way stop sign west bound on El Comal but not on Amaro Drive. A 24 hour electronic study can be done by a 3rd party to investigate its need on Amaro Drive. Study from 2019 did not justify the 3-way stop. TCC can request the stop signs on Amaro Drive if it is felt to be necessary.
